On July 1, 2002, we received notification from you that our May 8 response to your request for additional information regarding our Mid-Year Report (covering the period 1/1/02 - 6/30/01) was inadequate because we failed to provide all of the requested information. Specifically, you requested information concerning Schedule H4 and disclosed activity that was classified as exempt.

On our original filing of this report, activity was mistakenly classified as exempt where it should have been classified as administrative/voter drive. A subsequent amendment, sent via registered mail on June 12, 2002, corrected this error. Your May 8, 2002 response is incomplete because you have not provided all the requested information. For this response to be considered adequate, the following information is still required.


-Schedule(s) H4 of your report discloses activity classified as exempt. Please be advised that only state and local party committees are permitted to engage in exempt activities. 11 CFR §100.8(b)(10) Please amend your report to clarify this discrepancy.

An adequate response must be received at the Commission by July 17, 2002. Adequate responses received on or before this date will be taken into consideration in determining whether audit action will be initiated. **Requests for extensions of time in which to respond will not be considered.** Failure to provide an adequate response by this date may result in an audit of the committee. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action.

Electronic filers must file amendments (to include statements, designations and reports) in an electronic format and must submit an amended report in its entirety, rather than just those portions of the report that are being amended. If you should have any
