Please be advised for the current reporting period (07/01/2007-07/31/2007) no employee spent more than 25% of their compensated time on federal election activity, therefore all employee compensation information is detailed on Schedule H4. The Committee continues to use the best efforts procedures outlined by the FEC to obtain identification information for all individuals who contribute in excess of \$200 in a calendar year. All solicitations for funds request the required information for proper filing. Where there is incomplete information, a separate follow up letter requesting the complete information and advising of the requirements of federal law for the reporting of such information is mailed to the individual accompanied by a business reply envelope. Information that is received after the initial filing is reported in an amended filing to the FEC.
