
4. Expenditure Clarifications

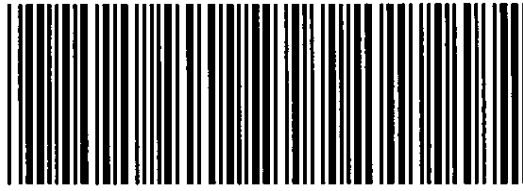
