The purpose of this letter is to respond to your letter dated August 15, 2016, regarding the FEC Form 5 July Quarterly Report (04/01/2016-06/30/2016) of the Fund for Economic Growth.

Your letter inquires about the reporting of contributions to the Fund for Economic Growth and suggests that its July Quarterly Report may have omitted this information. The Commission's regulations require the disclosure of contributions on FEC Form 5 only when a "contribution was made for the purpose of furthering the reported independent expenditure." 11 C.F.R.109.10(e)(1)(vi). The Fund for Economic Growth had no such contributions, therefore, no contribution disclosure was required and no amendment of its July Quarterly Report is necessary.
