Thank you so much for your help in this matter. I trust that the information provided will comply with your requests.

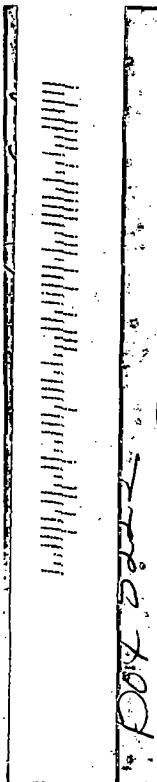
