1. Schedule A, supporting Line 12 of your report discloses transfers from "Off the Sidelines Senate 2016" that appear to be received through joint fundraising efforts. However, "Off the Sidelines Senate 2016" is not disclosed as a joint fundraising representative on your Statement of Organization. Please amend your Statement of Organization to disclose the joint fundraising representative as an authorized committee of the candidate or amend your report to provide clarifying information. (11 CFR §102.2(b)(1)(i) and 11 CFR §102.17(b)(2))

- Please be advised that the FEC Committee ID numbers for the following contributions from political committees appear to be incorrect: American Federation of State County and Municipal Employees AFL-CIO (C90011172), National Education Association (C30000848), and Planned Parenthood Action Fund (C90005471). Use of incorrect FEC Committee ID numbers may create difficulty in identifying the contributing committee for the public record. (11 CFR § 104.3(a)(4))

**Please note, you will not receive an additional notice from the Commission on this matter.** Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee
