Dear Ms. Davis,

In response to your letter dated May 20, 2011, attached please find the amended pages to the 2010 Pre-General report.

The individuals who had incorrect aggregate year-to-date figures have been corrected. This problem was due to duplicate records in our database and all applicable records have been merged to resolve this issue.

With regard to the ECTD totals for William B. Burgett, please note that there are two William B. Burgett's in our system. One is William B. Burgett at 2922 Lost Run Road, Fredericktown, OH 43019 and his EDTD is \$3,200. His son, William Brian Burgett, lives at 7274 Kendal Ln., Lewis Center, OH 43035 and has an ECTD of \$2,000.

Additionally, the ECTD figure for Alice Youngblood is correct. It appears as though she had a duplicate record in our system that was merged at some point. This issue was corrected on the most recent amendment to the 2010 October Quarterly.

The second point in your letter referenced the committee's compliance with regulations requiring the committee to disclose the identification of all individuals whose aggregate contribution exceeds \$200 in the election cycle.

The Portman for Senate Campaign has fully complied with the "best efforts" requirements. As required by Federal Law, all of our original solicitations include a clear and conspicuous request for the contributor information and informs the contributor of the requirements of federal law for the reporting of such information. Samples of solicitation materials are provided.


Additionally, our staff also makes follow-up phone calls as a final attempt to collect contributor information.






