Dear Ms. Amrhein:

This letter is in response to your letter regarding information needed for the above referenced report. I am sorry that we were unable to provide all the information at the time the report was due.

1. It does appear that we did accept two contributions which were from labor organizations, that we believed were from a PAC. These contributions of \$500 each from the PBA of Franklin Township and the Supervisory Officers Association have been refunded as soon as we became aware of the illegality of the contributions. The original report has been amended with all the clarifying information on the entities referenced in page one of the attachments. A copy of the refunded checks and the letter sent with them is attached.
2. Contributions made for the general election have been redesignated.
3. All of the information has been provided for the partners for contributions from LLC's. The LLC's are all considered as partnerships for income tax purposes and should be acceptable.
4. Regarding the contributions missing from the 48 hour reports, I am afraid that it was my error in using the software. I filed the reports using the FEC website directly and consequently missed one of the contributions from Siva Kolli, which was made on line

and did not import to the report probably because it was over the Memorial Day weekend. The other one was dated May 28 and though it was entered with a date of the 28th in the NGP software which is why it showed up in the July report , it was not deposited until later. This was again due to my own confusion over the NGP program. It was my error to be sure, but was inadvertent.

5. The contributions listed for Upendra Chivukula, the candidate, were entered incorrectly. They were both loans for \$25,000 each and there was a data entry error listing them as \$27,000.
6. We have provided the information for the identification of all of the individuals who contributed in excess of \$200. This has all been entered in the software program and is now included in the amended report filed on October 27, 2014. In every case we have used best efforts to secure the information.
7. The information on the loans made to the campaign by Upendra Chivukula have been added to the amended report. He made two loans of \$25,000 each on May 19, 2014 and May 23, 2014. These loans were made from personal funds and there is no due date or payment schedule involved.
8. The loans from the candidate were made from personal funds and this information has been acknowledged in the amended report.

Thank you again for all your help in this matter. I trust that the information provided will comply with your requests. We have made every effort to secure the missing information and have added it to the amended reports we submitted. Also, I have provided explanations as best as I can for how some of the errors occurred. I hope that this can be taken into consideration in your review.


Dear Mr. Rossman,
