By letter dated May 28, 2004 I acknowledged on behalf of the IGT PAC that we had exceeded by \$3,000 the \$5,000 maximum allowable contribution to Senator Daschle's campaign for the 2004 Primary election. At that time I also informed you that the corrective action we were taking was to request a refund of that \$3,000 from the Daschle Campaign Committee, "A Lot of People Supporting Tom Daschle".

Attached you will find a photocopy of the refund check which was recently received from the Daschle Committee. This check has been deposited back into the IGT PAC account and per your instructions will be reported on Schedule A supporting Line 16 for the period in which this check was received. Thank you for catching this error and so kindly providing guidance on how to resolve it. I am confident that we now have the necessary checks and balances in place in our PAC check request process to avoid such an oversight in the future.


