For this and any other receipt for which Employer and Occupation are not completely described, please be advised that I as Treasurer, Humane USA PAC's Assistant Treasurer, our consultant, and even our President, make phone calls and send letters at least twice to secure the information that you and the FEC require for each such contributor. On each donation form that comes in from a contributor, a clear message reads: 'Federal Election Commission rules require us to request your Occupation (and) Employer' and a line is given for the donor to easily include such information.' In some cases, one question is answered, but not both. In other cases, the individual is 'retired' and, therefore, necessarily has no employer. In each such case, this is noted as best as possible on the appropriate schedule. Once such a contribution has been received that does not include the necessary information, a letter is sent to the individual and / or a phone call is made to solicit the relevant information.
