1. Line 6(a) of the Summary Page represents the total cash-on-hand as of January 1, 2012. This figure should be the same on all the reports covering the calendar year. Please amend your report to clarify the change made in Line 6(a). (2 U.S.C. § 434(b)(1) and 11 CFR §104.3(a)(1))
2. The beginning cash balance of this report does not equal the ending balance of your Mid-Year Report (5/24/11 - 6/30/11). Please correct this discrepancy and amend all subsequent reports(s) that may be affected by the correction. (2 U.S.C. § 434(b)(1))
3. Please provide the amount(s) for Line(s) 7, Columns A and B of the Summary Page and amend your report and any subsequent reports that may be affected by this correction. (2 U.S.C. § 434(b))
4. Please provide the Column B totals for the Summary and Detailed Summary Pages and amend your report and any subsequent reports that may be affected by this correction. (2 U.S.C. § 434(b))
5. Your report discloses \$28,728.34 in total contributions on Line 11(d) of the Detailed Summary Page. However, you have failed to itemize these contributions on the appropriate lines of the Detailed Summary Page. Please amend your report to disclose the breakdown of this total on Lines 11(a) (a), 11(a)(ii), 11(a)(iii), 11(b), and 11(c). (2 U.S.C. § 434(b)(2) and 11 CFR

6. Your report discloses \$28,728.34 in Operating Expenditures on Line 21(c) of the Detailed Summary Page. However, you have failed to itemize these Operating Expenditures on the appropriate lines of the Detailed Summary Page. Please amend your report to disclose the breakdown of this total on Lines 21(a)(i), 21(a)(ii), and 21(b). (2 U.S.C. § 434(b)(2) and 11 CFR §104.3(a)(4))

7. Your calculations for Line 31, Column A, appears to be incorrect. Please provide the correct totals on the Detailed Summary Page. (2 U.S.C. § 434)(b) (7))

- It has come to the attention of the Federal Election Commission that the reports you have filed during the current election cycle do not reflect the appropriate coverage dates for quarterly filing status. Please be advised of the filing dates and coverage periods for the 2011-2012 election cycle and fill in the appropriate dates on Line 5 of the Summary Page. (U.S.C. 434(a) and 11 CFR §104.5(c))

Please note, you will not receive an additional notice from the Commission on this matter. Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. **Requests for extensions of time in which to respond will not be considered.**

Electronic filers must file amendments (to include statements, designations and reports) in an electronic format and must submit an amended report in its entirety, rather than just those portions of the report that are being amended.
