1. Receipt of funds from the American College of Rheumatology, RheumPACs connected organization, is strictly for the reimbursement of operating costs to the PAC in compliance with the U.S.C. However, some reimbursements to the PAC totaling \$1,023.18 were made by the American College of Rheumatology to RheumPAC more than 30 days after the reimbursable cost was paid by the PAC. This amount was transferred from RheumPAC to a separate fund not used in regards

to federal elections on September 20, 2018. This amount includes \$314.20 paid July 2, 2018, \$101.21 paid June 4, 2018, and \$607.77 paid January 31, 2018. These funds have been redesignated for the 2018 General election. An amendment to the RheumPAC 2018 second quarter report has been filed to report this redesignation.
