-Your calculations for Line 6(d) appear to be incorrect. FEC calculations disclose this amount to be \$75.83. Please provide the corrected total on the Summary Page.

-In order for your report to be considered complete, a Detailed Summary Page must be filed. 2 U.S.C. §434(b)

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter.
