To Whom It May Concern:


Enclosed is an amended *12-Day Pre-Election Report* for the November 7<sup>th</sup> General Election for the Precision Machined Products Association Political Action Committee (FEC ID number C00110858).

There are one major and four minor changes made to our original submission:

1. Page 1 of 5 of Schedule B, Itemized Disbursements, for line number 23, has been modified to delete the reference to a \$1,000 contribution to "Dickey for Congress Committee," House, Arkansas-4. Following submission of the Pre-Election Report, we were informed that Mr. Dickey's campaign does not accept PAC contributions. Our voided check was returned.
2. Because of the change mentioned above, the Total This Period line on page 5 of 5 of the Schedule B has been modified to show \$70,000 as the actual total amount of candidate contributions.
3. Item C on page 4 of 5 of the Schedule B has been modified to provide a correct P.O. Box number (26568 instead of 56268) and Zip Code (89126 instead of 89104) for Ensign for Senate.
4. The Detailed Summary Page has been modified to reflect the reduction in Contributions to Federal Candidates (line 23, A and B) from \$71,000 to \$70,000, and to reflect appropriate changes to lines 30 and 31 (A and B).
5. The Summary Page has been modified to reflect the correct Total Disbursements (\$70,000.00/\$70,023.94), and to show the now current Cash on Hand at Close of Reporting Period (\$4,060.53).

Please let me know if you require any additional documentation on this amended Form 3X.
