July Monthly Report (6/1/98 – 6/30/98)

This letter confirms your conversation with our accountant, Sandra L. Pack, on September 16, 1998, regarding the Commission's RQ-2 dated August 26, 1998 and RQ-3 dated September 16, 1998. Please regard this letter as our response.

Please note that the issues outlined in your RQ-2 and RQ-3 also are addressed via amended monthly reports for June (5/1/98 – 5/31/98) and July (6/1/98 – 6/30/98), which we submitted to the Commission on September 11, 1998.

Specifically, the totals listed on Line 11(a)(ii), 11(a)(iii), 11(d), 19 and 20, Column B of the Detailed Summary Page have been corrected on the July amended report. The Calendar Year-to-Date totals are derived by adding the current period figures to the year-to-date figures carried forward from the amended June report.

The correct outstanding balance (Schedule D) at the close of the period for the debt owed to Sandra L. Pack, CPA, LLC is \$5,355.80. The amount of \$3,355.80, shown on the original submission under the "Amount Incurred this Period" Column, was reported incorrectly due to a typographical error.

The nature of the debt owed to Image Maintenance (Schedule D) was for services rendered in producing an internal fundraising video. This information is reflected on the September 11 amended report.

Finally, all expenditures for video production (Schedule B) reported on the original submission were for production of an internal fundraising video. None of these expenditures were made on behalf of specifically identified federal candidates. These amounts are reported correctly on Schedule B of the amended report.
