Dear Ryan,

I am writing in response to your letter dated November 30, 2016 inquiring about a discrepancy in debt reported to Integral Resources Inc between the April Quarterly and July Quarterly FEC Reports.

While reviewing the reported debt, we discovered that the debt reported on the April Quarterly Report double counted an invoice in the amount of \$9,056.45 which was paid on April 1, 2016. Due to administrative error the April Quarterly Report was not properly amended. Correctly amended cover pages and debt page are attached showing an ending debt of \$47,248.10 which matches the beginning debt on the July Quarterly Report.

Certain column A figures on the cover pages of this report may not match the originally filed report. Russ for Wisconsin is currently undergoing a routine full cycle audit and a set of more comprehensive report amendments to correct any errors found will be filed in early 2017.
