- **2.** The beginning cash balance of this report does not equal the ending balance of your 2014 April Quarterly Report. Please correct this discrepancy and amend all subsequent reports that may be affected by the correction. (52 U.S.C. § 30104(b)(1) (formerly 2 U.S.C. § 434(b)(1)) and 11 CFR § 104.3(a)(1))
- **3.** Please provide a Schedule A to support the total amount disclosed on Line 11(b) of the Detailed Summary Page. All contributions from political committees must be itemized on Schedule A, regardless of the amount. (52 U.S.C. § 30104(b)(3)(B) (formerly 2 U.S.C. §434(b)(3)(B)) and 11 CFR § 104.3(a)(4)(ii))
- **4.** Please provide a Schedule A to support the total amount reported on Line 11(d) of the Detailed Summary Page. Each contribution from the candidate must be itemized on Schedule A, Line 11(d) regardless of the amount contributed. (11 CFR § 104.3(a)(4)(i))

matter. Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. Requests for extensions of time in which to respond will not be considered.

Electronic filers must file amendments (to include statements, designations and reports) in an electronic format and must submit an amended report in its entirety, rather than just those portions of the report that are being amended.
