This letter is in regards to ID# C00553420, New Mexicans for Priem.

Request that the committee be terminated. All activity ceased on June 3, 2014, when I was defeated in the Republican Primary Election in New Mexico.

There was no financial activity other than that reported on the June 30, 2014, financial report with the exception of a disbursement of \$750 to Cumulus Media for radio advertising in the spring of 2014, prior to the Primary Election.

New Mexicans for Priem has no residual funds. The campaign was largely self-funded. I have forgiven the balance of personal loans given *New Mexicans for Priem* to fund my campaign.

I apologize for the delay in requesting this termination action. I assumed that it had been accomplished concurrent with the June 30, 2014, report to the Federal Election Commission. Unfortunately, my campaign manager who was responsible to me for meeting all legal requirements died suddenly of a heart attack in early July 2014. This action on my part is an attempt to close out remaining issues related to the campaign that were not addressed earlier.

I assure you that my lateness in meeting this requirement is the direct consequence of a failure in administration within my campaign, and not an attempt to cover up any violation of Federal or New Mexico law, or rules and regulations of the Federal Election Commission.
