Covington & Burling LLP PAC made a \$2,000 pre-payment on 2/16/2011 (Transaction ID: SB21B.6504) to off-set in-kind contributions of staff time for non-compliance related matters. These funds have been retained by Covington & Burling LLP as an off-set to potential staff time in excess of \$5,000, as reported in our February Monthly report (Transaction ID: SB21B.4872). As reported in our 2012 post-general report, Covington & Burling LLP PAC's year-to-date federal operating expenditures totaled \$5,732.32. Accordingly, the \$2,000 prepayment has been used to off-set an excess of \$732.32 in federal operating expenditures, leaving a prepayment balance of \$1,267.68. In this reporting period, the remaining prepayment balance of \$1,267.68 is used to off-set \$694.44 in additional federal operating expenditures. The balance of the prepayment is now \$573.24, which Covington & Burling LLP will continue to retain.
