- (b) On January 22, 2010, Robert E. Rout, Senior Executive Vice President, Chief Financial Officer, Chief Administrative Office and Secretary of S&T Bancorp, Inc. ("S&T"), resigned from his position with S&T in order to pursue another employment opportunity. The resignation will be effective as of February 5, 2010 in order to facilitate the transition of functions responsibilities. Mr. Rout's decision was not based on any disagreement with S&T's operations, accounting principles or practices financial statement disclosures or otherwise.
- (c) Effective February 5, 2010, Wendy Bell, age 46, was appointed acting Chief Financial Officer and will assume Mr. Rout's responsibilities until the completion of S&T's search for a permanent chief financial officer. Ms. Bell has served as Senior Vice-President, Controller and Chief Accounting Officer of S&T since 2008. Ms. Bell served as S&T's Senior Vice-President and Controller from 2007-2008, and Vice-President and Controller from 1994-2007.

Ms. Bell was not appointed as acting Chief Financial Officer pursuant to any arrangement or understanding with any other persor and she has no reportable transactions under Item 404(a) of Regulation S-K. There are no family relationships between Ms. Be and any director or executive officer of S&T.
