2. Line 7, Column A of the Summary Page does not equal Line 31, Column A of the Detailed Summary Page. Please amend your report to correct this discrepancy. (11 CFR § 104.3(c))

- It has come to the attention of the Federal Election Commission that the reports you have filed during the current election cycle do not reflect the appropriate coverage dates for quarterly filing status. Please be advised of the filing dates and coverage periods for the 2017-2018 election cycle and fill in the appropriate dates on Line 5 of the Summary Page. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee.
