We have received your letter dated November 8, 1995.

With respect to the issue of providing the full name, mailing address, occupation and name of employer for all individuals who contribute more than \$200 in a calendar year, we have been following these procedures:

As evidenced by the samples of solicitations previously furnished, we include a clear and conspicuous request for the information. That request also indicates to the contributor that the reporting of the information is required by federal law. We have attempted to follow up with contributors who leave out information. We are still fine tuning our procedures. I will furnish at my earliest opportunity the latest version of a postcard request for the information.

Please help me understand what you mean when you say that the reports should be amended to reflect information submitted subsequent to the original report?

- During the first quarter of 1995 a check in the amount of \$1500 was inadvertently deposited in the federal account. As soon as we discovered this, we transferred the funds to our non-federal account. This was not related in any way to the funding of any type of activity in the federal account by a non-federal account.

- Thank you for your comment regarding information being disclosed on the wrong line of the Detailed Summary Page. We'll try to do better.


- As we discussed over the phone, we had notified the Commission of our change of Treasurer by letter which accompanied a previous filing.
