Dear Mr. Wetzel,

It is my understanding that you are the analyst assigned to oversee Monstah Pac's periodic Reports of Receipts and Disbursements. If that is not the case, kindly forward this Request for Administrative Termination to the appropriate RAD personnel.

On behalf of Monstah Pac, I electronically filed the Termination Report (TER) for Monstah PAC on April 12, 2020. For your convenience I have attached the first two pages of the TER for your reference labelled as attachments 1 and 2 to this correspondence respectively. As you can see from attachment 2, the Cash on Hand as of this date is \$0, with debts and obligations of \$117,806.97.

Attachments 3 and 4 are FEC summaries of the outstanding loan and debt (other than loans) balances set forth in Schedule C and D respectively. As they reflect, Monstah Pac has loans outstanding of \$51,852.66 (exclusive of interest), and debts (other than loans) outstanding of \$65,954.31 which total the \$117,806.97 amount referenced above.

As attachment 5 indicates, all debts (including outstanding loan balances) of Monstah Pac owed to Law Offices of David G. Eisenstein, P.C. were assigned to me in my individual capacity on November 28, 2016, a fact which I have been noting on the Reports (as Memos) filed on behalf of Monstah Pac since that time. As a result, the total amount owed to me in my individual capacity to date is \$108,352.66.

The remainder of the total of all debts including loans (exclusive of interest) is owed on the American Express credit card, a card issued on the strength of my credit at the time of issuance in response to the application which I signed and submitted to American Express, and therefore is a balance which I owe to American Express, and must pay with my own personal funds in light of Monstah Pac's insolvent status. That card is still and always has been, active, current, and in good standing, and I will continue to pay that indebtedness on a timely basis, in accordance with the payment terms of that credit card obligation.

Due to Monstah Pac's insolvency, I respectfully request as Treasurer of the Pac that the Commission provide the Pac an administrative termination, so that no further FEC Reports will be required to be filed.

The Help section of the FEC.gov website re: Terminating a committee suggests that Administrative termination is appropriate under these circumstances as the committee is:

- Not involved in any matter before the Commission; and
- The committee's aggregate reported financial activity for the past year is far less than \$5,000; and
- The reports disclose that the contributions for the previous year are all by me, and they were only for the purpose of maintaining the Pac long enough to obtain the Commission's approval of an administrative termination; and
- The committee's last report (the TER filed on April 12, 2020) showed that only minimal expenditures were made during the last quarter; and
- A primary purpose for filing its reports for over a year has been to disclose outstanding debts and obligations; and
- No reports have been missed during the approximately eight year existence of the Pac, which registered with the FEC in 2012; and
- Although the committee's outstanding debts including loans are not insubstantial, they are all related to the undersigned as obligee/obligor as reflected above; and
- The TER discloses that the outstanding debts and obligations do not present a possible violation of the Federal Election Campaign Act's contribution prohibitions and limitations; and

- The committee's outstanding debts and obligations exceed the total of the committee's reported cash on hand balance.

I founded and I largely funded Monstah Pac through my own funds and labor, and my law firm's provision of office space from which the Pac could operate. From time to time the Pac has made payments on its debts and obligations, all of which payments are reflected in the various reports filed by the committee with the Commission. Until this past year, or so, I have never believed that the amounts owed me by Monstah Pac could not be repaid to me. However, at this point it is clear to me that, under the circumstances, including the current severe recession, no repayment will be forthcoming.

American Express is the only other creditor referenced in the reports filed with the Commission, but it faces no jeopardy as I am able, willing and legally obligated to pay the balance on that credit card according to the American Express terms and obligations which I agreed to when I applied for and obtained the credit card.

Please advise of any questions you may have regarding this request for administrative termination.
