



-The beginning cash balance of this report should equal the ending balance of your Amended 30-Day Post-General Report, received 1/29/05. Please clarify this discrepancy and amend any subsequent report(s) that may be affected by this correction.


-Schedule A of your report discloses an aggregate year-to-date total(s) for a contribution(s) received from Thomas Tompkins which appears to be incorrect. Please amend your report to provide the correct aggregate year-to-date total(s).

Unlike previous election cycles, you will not receive an additional notice from the Commission on this matter. Adequate responses received on or before this date will be taken into consideration in determining whether audit action will be initiated. **Requests for extensions of time in which to respond will not be considered.** Failure to provide an adequate response by this date may result in an audit of the committee. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action.
