
Dear Mr. Evans:

In accordance with our discussions last week and this morning, please find enclosed an amendment, dated today, to the original Statement of Organization (dated October 21, 1982) of the Thompson, Hine and Flory Good Government Fund. This amendment corrects the original Statement in classifying the Fund as "(f) This committee support/opposes more than one Federal candidate and is NOT a separate segregated fund or a party committee," shows that the Fund has no "connected organization or affiliated committee," and updates the list of the Fund's officers.

As discussed, in the Fund's next report we will commence to reflect a payment by the Fund to Thompson, Hine and Flory (the "Firm") for certain personnel and other services provided by the Firm to the Fund. This amount will be approximately \$125 per quarter, which until now has been absorbed by the Firm, but which the Fund will hereafter pay to the Firm and report to the Commission accordingly.
