Dear Mr. Gibson:

In reply to your letters of January 13, 1994 and February 3, 1994, we would like to supply the following information:

- A. Concerning the thirty (30) day post run-off report (3/25/93 through 5/3/93), the following information should correct the report previously filed:
  - 1. The totals listed on lines 11(a)(i) and 11(a)(ii), Column B are incorrect and should be amended to read as follows: for line 11(a)(i) the correct amount is \$2,263.75 and for line 11(a)(ii) the correct total is \$4,959.21.
  - 2. Lines 31, Columns A and B should read \$5,200.00 and \$9,600.00 respectively.
  - 3. As to our itemization of the contributions reflected on Line 11(a)(ii), we received authorization from the Federal Election Commission to report these contributions in this manner. Although I do not have the exact date as to when we began reporting in this manner, I do know that we have done this for at least the last five (5) to six (6) years.
- B. Concerning the October quarterly report (7/1/93 through 9/30/93), line 23, column A should read \$1,700.00 and line 23, Column B should read \$4,800.00.


