Dear Ms. Sugarman:

This letter responds to the FEC letter dated July 19, 2016 to Gun Owners of America, Inc. ("GOA") regarding GOA's July 15 Quarterly FEC Form 5 report (4/1/16 through 6/30/16). I prepare required FEC Forms 5 and other reports and file them with the FEC on behalf of GOA, and have done so since 2010.

A 24-Hour Report was filed on April 4, 2016 covering the period from 4/1/16 through 4/1/16 for an independent expenditure of \$2,016.62 for last-minute Robo calls made on Friday, April 1, 2016, which was the date of public dissemination, in support of a Presidential candidate in an April 5, 2016 primary election. This 24-Hour Report was filed at 4:03 p.m. on Monday, April 4, 2016, which was less than two days late, as the 24-Hour Report should have been filed by 11:59 p.m. on Saturday, April 2, 2016.

I learned of this independent expenditure on April 4, 2016 when I reviewed an e-mail from GOA that was sent to me on April 4, 2016. Until I received this e-mail notifying me of the independent expenditure on April 1, 2016, I was not aware of this independent expenditure, or that an e-mail would be sent to me on April 4, 2016 regarding the independent expenditure.

Upon learning of the independent expenditure, I sent an e-mail on April 4, 2016 to GOA to ask whether there were any list rental expenses associated with the Robo calls that had been made on April 1, 2016. I received an e-mail response in the afternoon of April 4, 2016, which stated that an invoice had not been received from the list rental vendor, but that the list rental expenses would be "around \$500." After learning this, I immediately prepared the required 24-Hour Report and electronically filed it with the FEC on April 4, 2016. The 24-Hour Report included a Memo Text, which stated that the amount that was reported as attributable to the list rental vendor was an estimate and that an amendment to the 24-Hour Report would be filed after the correct amount was known.

After the invoice was received from the list rental vendor, I prepared an amendment to the 24-Hour Report covering the period 4/1/16 through 4/1/16 (originally filed on April 4, 2016) to change the Amount of \$500.00 (as estimated in the original report) to \$505.53 (the corrected amount based on the list rental vendor's invoice). After receiving assistance from the FEC's Electronic Filing Office, I prepared the amendment to the 24-Hour Report (originally filed on April 4, 2016), and electronically filed it on April 11, 2016.
