That transfer has been corrected to disclose it as a transfer from the NDP Non-Federal Account which was made for administrative expenses. -Due to an amended filing on previous report(s), the year-to-date totals on Schedule H4 for the Administrative Category were incorrect. With the filing of this amended report those totals are now correct. - The May Monthly report (4/1/09-4/30/09) has been amended to correct the transfer dates for the refunds received from SLP Sunset LLP and Friends For Harry Reid. The non-federal share of those refunds were transferred on June 9, 2009 for SLP Sunset LLP and on June 1st for Friends For Harry Reid. - Also included in this amended report are two in-kind receipts from the Democratic National Committee which were not available when the Committee's original report was filed on 6/19/09. -All disbursements that are reported on Schedule H-4 are administrative and are not in connection with a Federal candidate or Federal Election Activity. Salaries paid on the administrative split are for employees who spent less than 25% of their compensated time on Federal Election Activity. All payments for salaries, payroll taxes and health insurance premiums that are reported as administrative are not paid on behalf of employees who spent more than 25% of their compensated time on Federal Election Activity.
