Dear Mr. Evans:

In response to your letter (copy enclosed) of July 27, 1994, please accept this letter as a filing of clarification for the questions raised by the Commission's preliminary review of the report referenced above. We offer the following:

- Line 11(a)(i): The amounts reported on Schedule A in the box "Amount of Each Receipt this Period" represent **monthly** contributions. To arrive at the "Total This Period" from Schedule A that carries forward to line 11(a)(i), multiply each monthly receipt by the number of months covered by the report (e.g., 6 months x \$125 (50+20+30+25) per month = \$750). Please advise if our reporting of these monthly receipts should be in a different manner.
- We have taken note, for future filings, your instructions regarding the omission of schedules with no activity.
- Attached find an amended Schedule B which should support line 23 as requested.

This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-Line 11(a)(i) of the Detailed Summary Page of your report discloses a total of \$750 in Individual Itemized Contributions. The sum of the entries itemized on Schedule A, however, indicates the total to be \$125. Please amend your report to clarify the discrepancy.

-For future filings, please note that your committee need only file the pages on which you have itemized activity. Schedules with no activity may be omitted.

-Please amend Schedule B supporting Line 23 by providing the full name, address and office sought including state for each contribution made to a federal candidate or political committee. 11 CFR §§104.3(b)(3)(ii) and (v)

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter.
