On October 20, 2010, check #1055 in the amount of \$1,000.00 was made payable to the Committee to Elect Earl Ray Tomblin. This contribution was to help fund Tomblin in his re-election efforts for the 2012 West Virginia Senate race. The Supreme Court of Appeals of West Virginia ruled on January 18, 2011 that the state must hold a special gubernatorial election in 2011 to fill the vacancy resulting from Joe Manchin's election to the U.S. Senate. It was also determined that Earl Ray Tomblin is eligible to seek election for the remainder of the term. The Attorney General issued an opinion that funds raised for a 2012 campaign cannot be directly transferred to the 2011 campaign. Committees can either refund a pro-rated amount of the original 2012 election contribution or 'redesignate' the contribution for the 2011 election. In order to comply with this opinion, the Committee to Elect Earl Ray Tomblin is issuing refunds of all 2012 election contributions. The refund received (\$807.79) by the Patriot Coal Corporation PAC was pro-rated to cover expenses already incurred by the 2012 campaign (\$1,000, less \$192.21). We (Patriot Coal Corporation PAC) will reissue a check to the Committee to Elect Earl Ray Tomblin in the amount of \$807.79 to be used for the 2011 election.
