Dear Mr. Richardson:

This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-The Detailed Summary Page, on Line 18 Column A of your report, discloses \$115,556.45 in transfers from the non-federal account for joint activity for the reporting period. However, Line 21(a)(ii) Column A discloses \$104,674.49 as the non-federal share for joint activity for the reporting period. While the non-federal account is permitted to transfer funds to the federal account for allocable activity, transfers from the non-federal account for amounts greater than the non-federal share of allocable activity are prohibited by 11 CFR §102.5(a)(1)(i). Please clarify this discrepancy.

The Commission recommends that you immediately transfer back to the non-federal account, the amount which was transferred to the federal account in excess of the non-federal share. Although the Commission may take further legal action concerning this prohibited activity, your prompt action will be taken into consideration.

-It appears that your non-federal account has transferred-in money to your federal account to pay for direct candidate support activities benefiting Pirozzi for Congress (pertinent portion(s) attached). Furthermore, Schedule B supporting Line 23 discloses contributions in the same amounts to Pirozzi for Congress (pertinent portion(s) attached). Be aware that your non-

federal account may not reimburse your federal account for contributions to federal candidates. By definition, a shared activity is one which benefits both federal and non-federal candidates or committees.

Please clarify the nature of these activities, specifically whether non-federal candidates or committees were included. If non-federal candidates or committees were not included in the activities, the Commission recommends that you immediately transfer the funds received by your federal account for these activities back to the non-federal account. Although the Commission may take further legal action concerning this prohibited activity, your prompt action will be taken into consideration.

-Schedule H3 discloses a transfer(s) which is categorized as direct candidate support; however, a Schedule H2 has not been filed to disclose the allocation ratio. All committees are required to allocate the payment for direct candidate support in which the committee collects both federal and non-federal funds. The costs are allocated according to the time and space method or funds received ratio and reported on Schedule H2. 11 CFR §§106.5(f) and 106.6(d). Please file a Schedule H2 to disclose the ratio for the direct candidate support activity.

-Your report lists the name of the account on Schedules H3 as your committee's address. Be advised the account should be a non-federal account. Please amend your report to clarify the NAME OF ACCOUNT on Schedules H3.

-Itemized disbursements must include a brief statement or description of why the disbursements were made. Please amend Schedule H4 of your report to clarify the following description(s): "consulting". For further guidance regarding acceptable purposes of disbursements, please refer to 11 CFR §104.3(b)(3).

-Your report discloses a payment(s) on Schedule D to FHL&S, which has not been recorded on a disbursement schedule. Debt payments must be reflected on Schedule B or H4 as well as on Schedule D. Please amend your report to clarify this discrepancy. 2 U.S.C. §434(b)(5)(D)

-Schedule D discloses the outstanding balance at the close of the period for the debt owed to Henderson Co. to be \$15,000. FEC calculations disclose

this amount to be \$24,929.52. Please amend your report to clarify this discrepancy.

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter.
