Tennesseans for Senator Thompson (FEC ID# C00325498) received on April 17, 2002, your letter dated April 9, 2002, concerning our 2001 year-end FEC report.

We are amending Schedule D information, as requested. Please see enclosed.

With respect to disclosure of reattribution and redesignation information, we have reviewed the instructions in your letter and also in the Campaign Guide, and we believe that our reporting format meets the Commission's requirements fully. 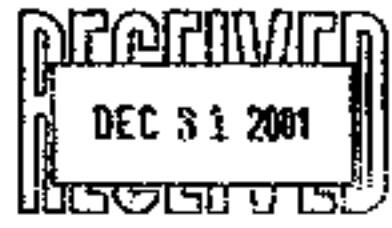

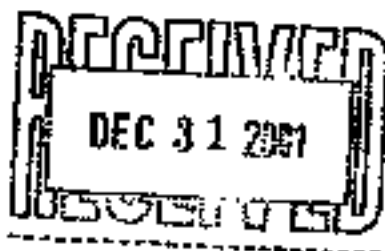
