This is in response to the June 11, 2014 request for additional information of the Matt Bevin for Senate campaign 12 day Pre-Primary report (04/01/2014-04/30/2014). This amended report will address the concerns you expressed about our unitemized receipts.

The last quarter leading up to our primary, we had a huge surge in national attention which led to a large increase in low dollar donors, and therefore a large increase in unitemized donations. We have properly disclosed all donor information that exceeded \$200.

The difference between itemized and unitemized on the amended report is due to the merging of duplicate donors - i.e. it is not due to new donors.
