This is in response to your letter regarding the Service Employees International Union's Committee on Political Education ("COPE") July 1999 monthly report. Schedule B of that report shows a contribution of \$10,000 to DASHPAC on June 28, 1999. This report is in error. A \$10,000 contribution was given to DASHPAC at that time, but only \$5,000 was placed into its federal account and the remaining \$5,000 was placed into its non-federal account. I have confirmed this with DASHPAC. The Committee further informs me that both \$5,000 contributions were reported to the FEC, although normally non-federal contributions are not reported to the FEC.

Your letter states that we exceeded our contribution limits on contributions to the Congressional Black Caucus PAC in calendar year 1999. 
