Line 15 of this report discloses a reimbursement from the Credit Union National Association for administrative expenses originally paid by CULAC. This entry does not represent a contribution. This reimbursement was made within 30 days as required by 11 C.F.R. 114.5(b)(3). Line 17 of this report discloses an audit adjustment of \$5,404.70. CULAC is making this adjustment to correct a discrepancy between its bank balance and FEC report balance. The discrepancy was caused by errors on reports covering activity prior to the 2015-2016 election cycle. The majority of these errors were incorrectly reported transactions related to the payment of PayPal processing fees for contributions. CULAC is reporting this adjustment based on advice from its FEC analyst.
