Public Affairs Support Services, Inc. (PASS) provides assistance to Stimson Lane Ltd. with the administration of its separate segregated fund, the Stimson Lane Ltd. Political Action Committee (Stimson Lane PAC), FEC TD Number C-00270421.

As I explained to you in our telephone conversation yester-day afternoon, PASS had just received in the mail the enclosed envelope addressed to the Federal Election Commission, which was stamped "Returned for Postage." When I opened it, I found it contained the signed original July 15 Quarterly Report of the Stimson Lane PAC, date-stamped by the FEC as having been received on July 18, 1994. Both the envelope as well as the original report it contained are enclosed.

I believe what may have happened is as follows:

Stimson Lane Ltd. is a subsidiary of UST, Inc., which also has a Federal separate segregated fund, the UST Executives, Administrators and Managers Political Action Committee (USTeam PAC), FEC ID Number C-00104851. Both PACs have the same officers. PASS prepares the FEC reports for both PACs, and forwards the completed reports for review and signature to the PAC treasurer. We attach an envelope addressed to the FEC to each original report for ease of processing.

Both the USTeam PAC's Monthly Report Due July 20 and the Stimson Lane PAC's July 15 Quarterly Report were signed on July 14, 1994. I have checked with the Commission and have learned that the USTeam PAC's Monthly Report Due July 20 was received by the FEC on July 18, 1994, the same day as the date stamp on the enclosed Stimson Lane PAC original. I was advised that FEC records show that the USTeam PAC's report was hand-delivered.

I believe that both the USTeam PAC and the Stimson Lane PAC reports were inadvertently forwarded to the Commission in the same courier envelope. I believe that when the FEC staffer handling the receipt of reports opened the courier pack, he or she assumed that the two-page Stimson Lane report was simply a copy of the USTeam PAC report's Form 3X, to be date stamped as confirmation of receipt by the Commission, with a self-addressed envelope attached in which to return the stamped copy.

Instead, it was the Stimson Lane report original, and the envelope was the one addressed to the FEC and meant to be used by Stimson Lane to forward the report to the Commission. This is the only way in which I can explain how a date-stamped report could wind up inside a scaled envelope returned to PASS for lack of postage.

We hope that, given this likely scenario, the Commission will accept the enclosed original Stimson Lane PAC July 15 Quarterly Report as having been filed on July 18, 1994. We recognize that this report was due on July 15, and regret the inadvertent mix-up in its mailing that resulted in its being filed one day late.
