Dear Mr. Ng:

I am in receipt of your letter of December 2, 1998, regarding our October 1997 Quarterly Report, covering the period of 7/1/98-9/30/98. This letter is intended to clarify and correct our reported designation of 1997-1998 cycle contributions to Rep. Jim Maloney (CT-D) for cited excess of the \$5,000 per election provision of law.

The specific contribution in question was in the amount of \$2,000 on 9/4/98, designated on our report as a Primary Election Disbursement. The error of this designation, after the close of the Connecticut primary period, was recognized by the candidate, reported to us, and a redesignation to the General Election was effected by letter (copy enclosed). This redesignation agreement, completed on the last day of the reporting quarter was inadvertently overlooked on our October Quarterly Report. The redesignation of this contribution should be noted on the candidate's filing for the cited quarter, and so noted on our filing for the same period.
