Your last FEC report, the 2017 12 Day Pre-Special Report, covered through March 29, 2017 and disclosed an ending cashon-hand balance of \$231,911.67 and loans owed to you totaling \$446,589.40 (please see https://docquery.fec.gov/pdf/549/201704139052094549/201704139052094549.pdf). If the committee used the residual funds to repay part of the loans owed to you, and you forgave the remaining loan balance, could you please indicate this in your statement? We would appreciate your prompt response, as we are currently trying to close out inactive prior cycle committees that last reported a high cash-on-hand balance, and this matter may be referable for further Commission action if it is not resolved.
