This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-Schedule D supporting Line 9 of the Summary Page discloses a \$58,000 debt owed to your committee by the Republican Fund For The Nineties State Account, for an allocation transfer.

Please be advised that Schedule H3 should be used to report all transfers received by your federal account, from your nonfederal account(s), to pay the nonfederal share of allocable expenses. In addition, transfers for shared activity must be made within a 70-day time period; no more than 10 days before or 60 days after the payment to the vendor. 11 CFR §§106.5(g)(2) and 106.6(e)(2) Please clarify the procedures you are currently using to pay the nonfederal share of allocable expenses. The Commission recommends that you take steps to correct any aconcompliance with the regulations.

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days
