**RE: Response Letter in Connection With July Quarterly Report (4/1/10 - 6/30/10)**

Dear Ms. Miller:

Thank you for your September 3, 2010, letter informing me of three compliance items that required the immediate attention of the Brightpoint Eclipse PAC ("PAC"). Please accept this letter as a full and timely response describing the actions the PAC has taken to comply with the Bipartisan Campaign Reform Act ("Act").

First, I hereby acknowledge that the PAC did initially accept contributions totaling \$16,500 from impermissible sources. I wish to bring to the attention of the Federal Election Commission ("FEC") that the PAC was advised by counsel of this error shortly after it occurred and took immediate steps to rectify this matter by refunding the full amount. Moreover, the July quarterly report of the PAC also fully disclosed to the FEC the original contributions to the PAC and the subsequent refunds made by the PAC. Further, I have been advised by counsel of permissible and impermissible sources of contributions and on a going forward basis internal controls have been adopted to avoid accepting checks from prohibited sources.

Second, I hereby acknowledge that the PAC made three contributions exceeding the limits. At the time the contributions were made, I believed that the contributions were within the limits. However, I was not aware of the distinction with respect to multicandidate status PACs, which resulted in three contributions exceeding the limit. I wish to bring to the attention of the FEC that the PAC has requested refunds for the excessive amounts. Enclosed, please find three letters dated September 10, 2010, which have been sent to the treasurers of the committees in question requesting refunds of the excessive amounts.

Third, it appears that in connection with the PAC's contribution to Ellsworth for Indiana, the contribution was disbursed after the Primary Election on May 4, 2010;

however, a scrivener's error was made that inadvertently disclosed the contribution on the July quarterly report as a Primary Election contribution. I wish to bring to the attention of the FEC that the report has been amended to show this contribution as a General Election contribution. Enclosed, please find a copy of the amended report.

On behalf of the PAC, I wish to express regret that the above described errors occurred. I understand it is our obligation to comply with all requirements of the Act and the PAC commits to strive to remain in compliance going forward. I also wish to bring to the attention of the FEC that we have sought the advice of counsel to advise the PAC on compliance matters going forward. For all the foregoing reasons, we respectfully request your acknowledgement of our compliance measures and that no further legal action be taken.

The Brightpoint Eclipse PAC donated to Hershman for Congress with check #20005 in the amount of \$5,000.00. We are happy to support Senator Hershman; however, 2 U.S.C. § 441a(a) prohibits a non-multicandidate political committee and its affiliates from making a contribution to a candidate for federal office in excess of \$2,400 per election. Furthermore, 11 CFR § 110.2(b) requires a refund or redesignation to occur within 60 days of receipt for excessive amounts. If the foregoing conditions for redesignations are not met within 60 days of the treasurer's receipt, Brightpoint Eclipse PAC is obligated to obtain a refund of the excessive amount.

Therefore, we are required to inform your campaign committee that a portion of the contribution will need to be refunded. The first \$2,400 should be applied to the 2010 Primary Election, the maximum amount permitted to be received from non-multicandidate PACs. The remaining \$2,600 will need to be refunded.



This letter is to acknowledge receipt of your letter dated July 11, 2010, in which Hoosiers for Rokita advised Brightpoint Eclipse PAC of a partial refund in the amount of \$200.00, check #1066.

We are happy to support Hoosiers for Rokita; however, 2 U.S.C. § 441a(a) a non-multicandidate political committee and its affiliates is prohibited from making contribution to a candidate for federal office in excess of \$2,400 per election. Furthermore, 11 CFR § 110.2(b) requires a refund or redesignation to occur within 60 days of receipt for excessive amounts. If the foregoing conditions for redesignations are not met within 60 days of the treasurer's receipt, Brightpoint Eclipse PAC is obligated to obtain a refund of the excessive amount.

Therefore, we are required to inform your campaign committee that an additional portion of the initial contribution will need to be refunded. The first \$2,400 should be applied to the 2010 Primary Election, the maximum amount permitted to be received from non-multicandidate PACs. The remaining \$2,400 will need to be refunded and our committee will reissue a check for the 2010 General Election in the amount of \$2,400.
