This transaction was reduced \$687.16 from \$6321 to \$5633.84 to subtract items that were non-federal activity that were incorrectly included with the federal activity. The remaining amount consists of exempt activity for producing a pep rally to distribute yard signs, banners, and coordinate volunteers in the days before election day. The \$687 was paid from non-federal funds - deleting this amount makes the debt amounts and payments correctly balance with subsequent reports.
