This letter is prompted by the Commission's preliminary review of the report referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. **Failure to adequately respond by the response date noted above could result in an audit or enforcement action.** Additional information is needed for the following 2 item(s):

1. Schedule B supporting Line 23 of your report discloses in-kind activity which appears to be reported incorrectly. Please be advised that in-kind contributions made to federal candidates and political committees should be disclosed as non-memo entries so that the total amount of contributions to federal candidates and political committees (including in-kind contributions) are properly included on Line 23 of the Detailed Summary Page, in order to avoid inflating the cash-on-hand amount. Please amend your report to properly disclose the in-kind activity or provide clarifying information. (11 CFR §104.3 (b)(1))

2. Please identify the name of the recipient candidate/committee for the in-kind disbursement made to "International Trade Center" disclosed on Schedule B for Line 23. (11 CFR §104.3 (b)(3))

**Please note, you will not receive an additional notice from the Commission on this matter.** Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. **Requests for extensions of time in which to respond will**


