This amendment is being submitted to provide the FEC with notice that WFW Action Fund Inc., FEC ID# C00698936, intends to change its designation from an independent expenditure-only committee (Super PAC) to a Hybrid PAC effective March 5, 2020.  
Consistent with the stipulated judgement in Carey v. FEC, this committee intends to establish a separate bank account to deposit and withdraw funds in unlimited amounts from individuals, corporations, labor organizations, and/or other political committees. The funds maintained in this separate account will not be used to make contributions whether direct, in-kind, or via coordinated communications, or coordinated expenditures, to federal candidates or committees.
