With respect to item 2 of the RFAI, this Committee exercises its best efforts to report the complete identification of all contributors who contribute in excess of \$200 in a calendar year. First, this Committee makes a clear and conspicuous request for this information on its website donation platform and on the standardized solicitation materials distributed to prospective contributors in advance of events and in other communications from fundraising personnel to prospective contributors. Second, contributors who do not provide that information originally receive a subsequent request for that information through phone, email, or regular mail that is not itself a solicitation. Third, if and when that information is obtained after the filing of a report, the subject report will be amended. However, no additional information has been received with respect to the subject report as of this date. Further, the committee notes the substantial reticence of conservative donors to provide personal information to a government that actively spies on its citizens and openly targets individual conservatives for abuse and harassment through government action.

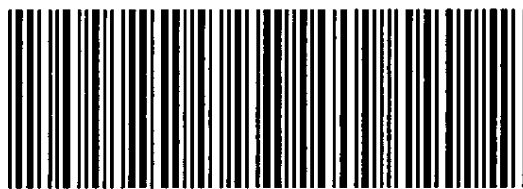
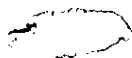
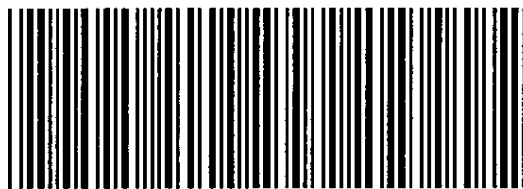
