Dear Mr. Furman,

We have amended our previously filed FEC reports to correct mistakes made in the way the campaign's credit card debts and obligations were reported. Mistakenly, credit card vendor obligations for less than \$200 were not reported and in some cases, the money owed was reported as an expenditure rather than a debt and obligation. The campaign has carefully reviewed the reports and corrected those mistakes.

We also made additional corrections to contribution and disbursements that we found. All of those changes are included in the amendments we are filing. We have spent the time to make all the necessary corrections.
