

Forever May She Fly



My name is GREGORY MARK GUILLAUME. I reside in Orange, California, and I am running for the office of the president of the United States as an independent, write-in candidate. I would like your vote!

I PLEDGE to uphold the constitution; to protect the American people and our allies; to serve with fairness and impartiality; to proceed cautiously and solicit expert opinion when confronted with issues for which I lack sufficient knowledge or solutions; to speak constructively of fellow politicians; to not publically ridicule or belittle any sect. I AM DEDICATED to fiscal conservatism; small government; pro-environment; and a powerful military.

I have applied to the Federal Election Commission via Form 1 and 2 and will be a self-funding candidate.

My Fifteen-Point, Platform Issues and Positions, written March 2016, are...

1. DEFENSE... The world is more dangerous today than it was during the cold war. There are too many nations who are anti-American and who have or soon will have nuclear and inter-continental launch capabilities. To thwart this threat, our military and national defenses will be strengthened to near cold war levels.

2. ISIS... Not since Hitler and the Nazi party has there been such a threat as ISIS. Through a coalition of America's global partners, ISIS will be confronted and eliminated.

3. IMMIGRATION... We welcome legal immigrants. But the millions of people sneaking into this country illegally is one of America's biggest problems. Illegal immigration is the root cause of dozens of other serious issues for Americans including skyrocketing welfare and medical costs, crime, lack of jobs, increased population straining water and food resources, and a slowing economy. Politicians have sidestepped the illegal immigration issue for forty-plus years. While I realize the personal suffering and sensitivity of this issue, illegal immigrants will be deported and the borders will be sealed.

4. ANCHOR BABIES... Currently, U.S. citizenship is granted to children who are born in America but are of non-U.S. mothers. These "anchor babies" are then American citizens for life and are entitled to welfare and other freebies. The hope to have an anchor baby in the U.S. is a huge lure for illegal immigrants. Other countries stopped this practice of granting anchor-citizenship and entitlements years ago. The antiquated practice of Anchor Babies will be stopped.

5. POLITICAL CONTRIBUTIONS... Today, super-pacs are used to raise unlimited sums of money from corporations, unions, associations and individuals, and then spend unlimited sums to overtly advocate for or against political candidates. Super-pacs are misused and promote corruption in Washington. Super-pacs will be abolished.

6. INFRASTRUCTURE... America's roads, bridges, water pipelines, and railways are deteriorating and failing. The infrastructure will be repaired over the next twenty-years.

7. ENERGY... All atomic *fission* power plants -- which are inherently dangerous, radioactively dirty, impossible to dispose of spent fuel, and potential targets for terrorists -- are to be closed by 2036. On the other hand, funding and research for atomic *fusion* power plants -- which would be clean and safe -- will be significantly increased. The national goal will be to have the first fusion power plant -- of which there are currently none -- in operation by 2036.

8. SAME SEX MARRIAGE... While not personally condoned, same sex marriage should be allowed.

9. ABORTION... Abortion should be allowed only in the case of rape, incest, or impending harm to the mother. Fetus parts absolutely cannot be sold.

10. CORPORATE TAX RATES... Middle class jobs are the economic engine of America. To fuel that engine, the middle class is dependent on corporations for employment. The more jobs created, the stronger the economy and America. To generate those jobs, corporations must be globally competitive. To be globally competitive, American corporations must have tax rates comparable to the 25% tax rate for non-American corporations. At 38%, America has one of the worst corporate tax rates in the world. The corporate tax rate will be reduced to no more than 24.5%.

11. CORPORATE INVERSIONS... Inversions are where U.S. firms merge with foreign firms to pay less in corporate taxes. Corporations that connive and maneuver their legal American residence to off-shore locations to reduce or avoid their corporate tax base are despicable and are an insult to the American people by shifting their tax burden to you, the general public. Corporate inversions will be stopped.

12. CORPORATE SOCIAL RESPONSIBILITY... While corporations and Wall Street have the legal right to generate large profits, they also have the unwritten obligation to have a conscience, to not gouge, and to not take advantage of the American people. Because greed covertly infiltrates and corrupts big businesses, appropriate regulations and adequate personnel will be put in place to regulate U.S. corporations, hedge-fund managers and Wall Street.

13. PRICE REGULATION OF SEVEN ESSENTIAL COMMODITIES... A company with a new product or new service should have the right to charge as they see fit as no one is immediately dependent on their product and no pricing precedent has been set. (As an example, when gasoline was first discovered, no one wanted it so any asking price would have been allowable.) On the other hand, today there are seven essential commodities that are so engrained and vital to the American way of life that their pricing must be regulated and safeguarded from corporate greed and the lack of competition. These seven commodities are: prescription medications, healthcare, gasoline, diesel fuel, water, electricity, and natural gas. American's cannot tolerate 92,000% increases in medications or large, manipulated spikes in electricity and gasoline prices due to corporate greed and unconscionable corporate gamesmanship. Legislation to enforce pricing of these seven essential commodities will be enacted and enforced.

14. ENDANGERED SPECIES... Manta rays, white rhinos (there are only 3 left) and thousands of other species are being eliminated at an astonishing rate by both legal and illegal hunting. We must rally as part of the global community to bring a halt to this unnecessary killing. If we do not, a century from now people will look back at this generation and wonder why we did nothing to stop the slaughter and extinctions. For those who feel nothing can be done, we must remember that it is better to light a single candle than it is to curse the darkness. America will take a stronger position to protect global wildlife.

15. PLASTIC DRINK BOTTLES AND PLASTIC SHOPPING BAGS... To some, this may seem a trivial issue. After all, how much harm can a plastic drink bottle or plastic shopping bag cause? Well, in the Pacific Ocean, there is an area the size of Texas and several miles deep where plastic bags and other plastic wastes have accumulated. This accumulation of plastic waste is killing marine life and negatively altering the eco-system. On America's local scenes, plastic drink bottles and plastic shopping bags litter the roads and country sides and require millions of dollars in clean-up funds. By 2021, plastic drink bottles and plastic shopping bags will be phased out and replaced with bio-degradable replacements.

IN CONCLUSION... For thirty years, I was a loyal but oblivious party member that blindly voted straight down my party ticket.

But in the past few years, I have come to realize a disturbing truth: too many politicians -- both Republicans and Democrats alike -- believe more in the needs of their party and in the needs of their special interests than in the needs of America. That, and one too many government shutdowns, caused my thinking and voting to change.

Today I vote for the proposition that helps America regardless of the person or party promoting the idea. I would like your vote but if you can't vote for me, then regardless of party, vote for whatever or whomever truly helps America!
