Dear Mr. Bennett:

This is our response due May 16, 2008, in reply to your inquiry of April 16, 2008 regarding the transfer of \$27,000 from the federal account to the non-federal account.

This was done because our Committee has determined that we established a federal account in error. We believed that the filing fees paid by individuals to our Committee's convention to stand for nomination as the Republican candidate in a special election to fill a vacancy in the U. S. Congress from the 1st District were required to be deposited in a federal account. We have since learned this is not the case and, therefore, prefer to concentrate our financial activities using our non-federal account. The entire amount of \$27,000 consisted of proceeds of those filing fees or voluntary fees paid by individuals in order to be elected as delegates to the said convention.

As I have declared already, none of any funds we received or disbursed were used as a contribution to any candidate for any federal office. Therefore, all expenses are non-federal connected and, therefore, are all allocated as non-federal expenses.

Our committee is comprised of volunteers. I am a volunteer treasurer. It is not a full time position. We are doing the best to our ability to comply with your regulations.
