

I am writing in response to your letter dated June 14, 2016 inquiring about Column B on our April Quarterly report. 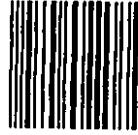
