

10/22/10 \$2000


However, as a multi-candidate committee we are permitted to contribute no more than \$5000 to any candidate with respect to a specific election.

In order to bring both of our committees into compliance with federal election laws, we are writing to request that you refund to Victory NOW PAC the \$1000 that was contributed in excess of the federal election law limits.
