First Horizon Corporation Federal PAC (the Committee) files this Form 99 in response to your Request for Additional Information (RFAI) dated February 1, 2023.

The increase in receipts was unintentionally omitted from the original Pre-General Report FEC-1647891, which was filed on October 24, 2022. To correct this omission and to submit an accurate report, the Amended Pre-General Report FEC-1662698 was filed on November 28, 2022, only 20 business days after the October 27, 2022, deadline.

The additional funds reflect a transfer from an affiliated PAC, First Horizon Corporation LA Fed PAC, Committee Number C00406066, to terminate the affiliated PAC. The PAC report for the affiliated PAC which reflects the transfer is FEC-1636639 dated October 12, 2022. FEC Approval for termination of the First Horizon Corporation LA Fed PAC was filed October 17, 2022.

The Committee also notes that it was experiencing technical issues with the FECFile software which limited the ability to view a PDF rendering of the Pre-General Report prior to filing. On December 6, 2022, after the Committee continued to experience these software issues when preparing the Post-General Report and the Amended Pre-General Report, an employee in our technical support group met by teleconference with FEC employees in Technical Support and Systems Infrastructure to work out a solution to the technical problems. With the improved functionality we now have in FECFile usage, we do not anticipate further problems viewing reports prior to filing. Being able to view the reports prior to filing will help assure accuracy of reports.

Finally, and most importantly, notwithstanding that it did file the Pre-General Report, the Committee notes that it was not required to file this report. The Committee files on a quarterly reporting schedule and did not make contributions or expenditures in connection with the 2022 general election during the pre-general reporting period. As such, the Pre-General Report was not owed and the financial activity that is the subject of this RFAI was timely disclosed by the December 8, 2022, Post-General Reporting deadline.

We apologize for the confusion due to our Amended Pre-General Report. Please let us know if you have any further questions.
